- \* Prepayment for services are available to those Guests who prefer contactless checkout.
- \* Additional time is included between appointments to prevent a Guest from making contact with another Guest.
- \* Individuals accompanying a Guest scheduled for services will not be allowed in the salon at this time unless accompanying an individual with a special need or a minor.
- \* Each Guest is required to have their temperature taken via a contactless thermometer as well as sanitize their hands with hand sanitizer supplied by the salon or are required to wash their hands in the required amount of time of twenty (20) seconds upon arrival and before leaving.
- \* Each Guest is required to wear a mask when they enter the salon either of their own or we will provide a new disposable mask for you. Under the age of 2 are exempt.
- \* No blow drying will be offered at this time.
- \* Your stylist will thoroughly sanitize their hands before your service.
- \* Your stylist will wear a clean cloth mask and apron for your service.
- \* All products used during your service will be placed on the trolley for disinfection and disposable items will be used when possible.
- \* All tools and surfaces will be wiped thoroughly and disinfected before and after each Guests' service.
